# Arlington County Community Services Board Executive Committee Meeting September 8, 2014 Drewry Center - Rm. 107 6:00 p.m.

The September 8, 2014 Arlington County Community Services Board (ACCSB) Executive Committee meeting was convened by the ACCSB Executive Committee Chair James Mack at 6:00 p.m. The meeting was held at the Drewry Center, 1725 N. George Mason Drive, Arlington, Virginia.

#### Approval of the July 7, 2014 and August 11, 2014 Executive Committee Minutes

Chair Mack called for a motion to approve the July 7, 2014 ACCSB Executive Committee meeting minutes. Ms. Skelly motioned to approve the minutes, Ms. Hermann seconded the motion, and the minutes were approved with no corrections.

Chair Mack called for a motion to approve the August 11, 2014 ACCSB Executive Committee meeting minutes. Ms. Hermann motioned to approve the minutes, Ms. Jones seconded the motion, and the minutes were approved with several corrections.

### **Update: Mandatory Outpatient Treatment Discussion with Barbara Favola**

Ms. Hermann announced that a meeting is being held at 1810 Edison Street on September 9<sup>th</sup> to discuss Mandatory Outpatient Treatment (MOT). She reported that as a result of the meeting held by Senator Favola on August 6th to discuss proposed legislation for MOT, the CSB was requested to provide feedback on MOT code and code language revisions to Senator Favola by September 19<sup>th</sup>. Leslie Weisman, Bureau Chief, Client Services Entry, in collaboration with CSB staff, CSB members, Treatment Advocacy Center staff, NAMI representatives, a consumer staff member and the Arlington Public Defender and Sentencing Advocate, will develop the feedback document.

#### **CSB Fee Scale Recommendation**

Ms. Friedman stated that the CSB is required by County policy to review the client fee schedule annually (*Refer to Handout*). She noted that the CSB full board agreed to a recommendation to the County Board in FY13 to increase the minimum client fee from \$4.00 to \$5.00 for FY14. She further noted that in FY14 the full board agreed that the minimum fee should remain flat. Ms. Friedman asked the committee if they would like to increase the minimum client fee in FY15 to the County Board or retain the fee at \$5.00. The committee agreed to recommend no increase in the minimum client fee to the County Board. Ms. Friedman stated that, due to the absence of the Administrative Officer, she has requested that the Finance and Budget Analyst prepare an updated fee schedule for approval at the October 15th full board meeting.

## **CSB Annual Retreat Planning**

Chair Mack announced that the Annual CSB Retreat will be held Saturday October 18, 2014 from 9:00 a.m. to 2:30 p.m. in the George Mason Center (GMC) Auditorium (*Refer to Handout*). The committee discussed who they would like to invite as the lunchtime speaker and suggested several topics for discussion. It was noted that Delegate Brink has retired from the General Assembly and has accepted the position of Deputy Commissioner for Aging Services in the Department of Aging and Rehabilitative Services. Mr. Richard "Rip" Sullivan was elected to fill Mr. Brink's seat in a special election that was held on August 19th.

#### **Brief Updates/Information**

Ms. Friedman reported that the DHS Director is still in the process of conducting preliminary telephone interviews for the vacant Behavioral Healthcare Division (BHD) Chief/Community Services Board (CSB) Executive Director position.

- Peer Recovery/Recovery Support Staff population served; adults with substance abuse disorders
- Arlington Jail Addictions, Corrections and Treatment (ACT) Unit Case Management population served; adults with substance abuse disorders
- Drug Court Substance Abuse Counselor population served; adults with substance abuse disorders
- Mental Health Therapists in the Jail (Substance Abuse Committee special support) population served; adults with substance abuse disorders

#### Child and Youth (CY) Committee

- Behavior Intervention Services (BIS) Provider population served; caregivers and teachers of children with behavioral challenges (80% of children served range in age from 3 to 10)
- Resource Development Dollars

- Chair Mack announced that, due to the Veteran's Day holiday on November 11<sup>th</sup>, the CSB Executive Committee will change its meeting date to November 3<sup>rd</sup>.
- Chair Mack announced that September is National Recovery Month. National Recovery Month is sponsored nationwide by the Substance Abuse and Mental Health Services Administration (SAMSHA). The theme this year is Speak Up, Reach Out. Lizabeth Schuch, BHD Recovery Manager, is coordinating a Speak Up, Reach Out event. The event will be held September 24th at Bus Boys and Poets from 6:30 p.m. to 8:00 p.m. Individuals in recovery will tell their stories in various formats (speaking, video, poetry, etc.).
